**RELEASE**

This Release is made by the "Participant" or "Participants" in the "Midwest Donzi Club or MWDC", a Texas Limited Liability Corporation for the "Fun Run" also know as the "Awakening of the Horses Ten" or AOTH 10" .

W I T N E S S E T H :

**WHEREAS**, the MWDC sponsors a Fun Run which allows boat owners to operate their boats together in an organized fashion on Lake Cumberland,

**WHEREAS**, Participant expressly acknowledges and agrees that the MWDC has made no representations, promises, guarantees or other statements of any kind whatsoever concerning the size or seaworthiness of any boat which Participants will be aboard, the speed or direction or distance the boat will be traveling, the prevailing sea conditions or wake the boat will encounter at any time, the safety of the boat or its equipment, or the boat-handling skills or reputation of the boat's owner, captain or crew; and

**WHEREAS**, Participant expressly acknowledges and agrees that boating and Fun Run activities are very dangerous and unpredictable, that such activities inherently involve the risk of serious injury, death, and/or property damage, and that an Participant must at all times pay close attention to the boat, other boats in the Fun Run, and to the conditions at sea for his or her own personal safety; and as a condition of operating or riding in a boat, a safety vest will be required to be worn by all Participants and the captain must utilize an ignition cut off lanyard if available, and

**WHEREAS**, Participant expressly assumes full responsibility for the risk of personal injury or property damage while Participant is aboard their boat or any other boat owned and operated by a Participant in the Fun Run. The MWDC also assumes that either owners or passengers on boats of Participants are familiar with boat docking, mooring, and the use of dock facilities. As such, the Participants are familiar with the inherent hazards, such as dips, protrusions, or slippery surfaces on the dock facility, boats, or the land immediately adjacent to the waterfront and the dock that may represent a potential safety risk.

**NOW, THEREFORE**, in consideration of the MWDC's permission granted to Participant to be operate or ride in a boat in the Fun Run, and other good and valuable consideration, receipt of which Participant acknowledges, Participant does hereby absolutely release, waive, discharge, covenant not to sue, and agrees to indemnify and hold harmless the MWDC, its officers, managers, directors, agents, sponsors, donors, boat owners, captains, crew members, the city and county where the Fun Run is held, each of their respective predecessors, successors, and assigns, and all other persons connected directly or indirectly with the operation of the Fun Run ("Releasees"), from and against all liability to Participant, his/her spouse, children, legal representatives, heirs, successors, and assigns, for any and all losses, expenses or damages, and any claim for damages resulting therefrom, on account of death, personal injuries, or property damage sustained by Participant while the Participant is aboard the boat of any Participant in the Fun Run or while upon the Fun Run premises during any Fun Run activities. ***Participant understands and agrees that this Release specifically includes and waives any claims based on the negligence of the Releasees.***

Participant further releases the Fun Run from any claim whatsoever on account of first-aid treatment or other medical services rendered during Participant's participation in the Fun Run activities.

Participant expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Kentucky, and that if any portion thereof be held invalid, it is agreed that the balance shall, notwithstanding, continue in its full legal force and effect.

***PARTICIPANT STATES THAT HE/SHE HAS CAREFULLY READ ALL PAGES OF THIS RELEASE, UNDERSTANDS THE CONTENTS AND MEANING OF THIS RELEASE, AND SIGNS THIS RELEASE AS HIS/HER OWN FREE ACT. THE MWDC RESERVES THE RIGHT TO REFUSE ENTRY TO ANY PARTICIPANT.***
